2019 Summer Preview Membership

A Preview Member may join Mt. Hawley Country Club after approval by the Membership Committee and Board of Governors for a one-time payment set forth in the schedule below. That payment shall be the inclusive sum of membership dues and capital charges for the period of May 1, 2019 through September 2, 2019. Food and Beverage spending minimums will be waived during the preview period. An early enrollment option is available for those Preview Members desiring to use the Club prior to May 1, 2019. Additional dues payments will be required for each month the Preview Member desires to use Mt. Hawley.

During the tenure of Preview Membership, the Preview Member will have access to all club services normally available to their specific class of membership, with the exception of major Club tournaments or events as determined by the Club. In addition to any individual charges, the Preview Member shall be further obligated to pay all charges incurred by their family and invited guests while at the Club. This includes any applicable service charges.

The Preview Membership period and all Preview Membership privileges will end on September 3, 2019, unless the Preview Member has, prior to that date, executed and delivered to the Club the [2019 Summer Preview Membership Promissory Note] by which the Preview Member will commit to membership as a member of the class of membership for which the Preview Member applied for a minimum of one year. At the time of commitment, a portion of the preview dues amount will be credited against the applicable Initiation Fee; as well as the number of preview months credited as part of the first year membership term. After conversion the member will be responsible for all dues, spending minimums, capital charges, and other fees or charges normally associated with the class of membership for which they were accepted.

The Preview Membership will be available one time only to any individual or family. If the membership is not converted at the expiration of the Preview Term, the candidate may only reapply for membership as set forth in the bylaws of the Mt. Hawley Country Club. The Preview Membership is open to new prospective members and to previous members of Mt. Hawley Country Club who resigned prior to May 2015.

1. Commitment to membership for a preview term through September 2, 2019. In addition to the Preview Dues amount already required, I hereby obligate myself for the payment of all applicable fees and charges (including service charges) during the Preview Membership term, subject to the terms associated with the Preview Membership Initiative. This includes any and all charges incurred by my immediate family and invited guests while at the Club.
2. Termination of privileges or membership conversion at conclusion of the Preview Membership term. On September 3, 2019, my Preview Membership and all of my privileges thereunder shall terminate unless, prior to that date, I deliver to the Club an executed 2019 Summer Preview Membership Promissory Note. By executing that note, I will be committing to membership as a member of the class of membership for which I applied for a minimum of 1 year.

3. Privileges and limitations during preview period. During the preview relationship, I shall be entitled to the use of the Club facilities and involvement in all Club activities (excluding major Club tournaments/events as determined by Mt. Hawley Country Club) and usage privileges as established by the Club. Additionally, I understand my preview relationship is not transferable or refundable and provides no voting rights.
4. Mt. Hawley Country Club By-Laws. I agree to be bound by the By-Laws and Rules and Regulations as established and may be amended by Mt. Hawley Country Club from time to time.
5. Recallable preview membership. The Club has the absolute right and discretion to recall my preview membership at any time before the membership terminates. If the Club exercises its right, I remain obligated and promise to pay dues, fees, and charges incurred during the term of my preview membership. There will be no refund of fees, dues, or other charges I have paid.
6. I understand that should I exercise the option to convert the membership by executing the 2019 Summer Preview Promissory note, I will be obligating myself to the terms of membership for a minimum of 1 year and agree to pay all applicable dues, fees, charges, assessments during that time.
7. I understand the Preview Membership will be available one time only to any individual or family. If the membership is not converted at the expiration of the Preview Term, I may only reapply for membership as set forth in the bylaws of the Mt. Hawley Country Club.

**2019 SUMMER PREVIEW MEMBERSHIP
PROMISSORY NOTE**

For and in consideration of value received, including, without limitation, the extension of privileges under the 2019 Summer Preview Membership Program, the undersigned (the "**Member**") does hereby covenant, agree and promise to pay to the order of **MT. HAWLEY COUNTRY CLUB**, an Illinois not for profit corporation (the "**Club**"), the principal sum of Dollars (\$) () without interest, payable as hereinafter set forth.

In the event I resign from the **Club** on or before May 1, 2020 (the "Membership Term Commitment Date"), payment in full of the principal sum will be due on the date I resign from the **Club**, and I agree to pay the principal sum in full on the date I resign; provided, however, the principal sum payable will be reduced by the sum of the monthly membership dues I pay to the **Club** for monthly periods beginning after the date of this Promissory Note. If I do not resign from the **Club** prior to the Membership Term Commitment Date, and provided I am current in my regular monthly payments due to the **Club** as billed to me by the **Club** on the Membership Term Commitment Date, this Promissory Note shall be deemed paid in full on the Membership Term Commitment Date.

Notwithstanding the foregoing, the full unpaid amount of this Promissory Note shall, at the option of the **Club**, become immediately due and payable upon the occurrence of any of the following prior to the Membership Term Commitment Date:

1. The death of the **Member**; or
2. The non-payment, when and as due, of any monthly billing statement submitted by the **Club** to the **Member**.

In the event **Member** is in default on this Promissory Note, interest shall commence to accrue on the then remaining principal balance from the date of default until this Promissory Note is paid in full at an interest rate of Ten Percent (10%) per annum with interest compounded every sixty (60) days after the date of default by adding accrued interest to the principal balance. **Member** will be in default on this Promissory Note in the event (i) a monthly billing statement submitted to the **Member** is not paid in full when and as due, or (ii) in the event the full amount due under this Promissory Note becomes due and payable and the **Member** does not pay the same within ten (10) days of the date of demand for payment.

Member does, in addition, hereby:

- (a) waive presentment of this Promissory Note for payment, notice of dishonor, protest and notice of protest;
- (b) agree, that in the event legal proceedings are instituted to collect any amount due upon this Promissory Note, to pay to the **Club**, in addition to the principal sum hereof, all costs and all expenses of such proceedings, including reasonable attorneys' fees; and
- (c) agree, that this Promissory Note shall inure to the benefit of, and shall be binding upon the heirs, the legatees, the devisees, the executor or the administrator, the assign, or the assigns, and the successor, or the successors, of the **Member** and the **Club**.
